This option is the correct action to resolve the issue of MWI not working when a new message is received. The SIP server list on the Cisco Unity Connection port group defines the destination addresses for SIP messages, such as MWI notifications, that Unity Connection sends to Cisco UCM. If the SIP server list does not match the device pool settings on the SIP trunk, Cisco UCM may not be able to route the MWI notifications to the correct devices, and may respond with a SIP 503 Service Unavailable message. Each assertion is an XML document that contains trusted statements about a subject including, for example, username and privileges. SAML assertions are usually digitally signed to ensure their authenticity.
